## MESSAGE FROM THE PRESIDENT Mr Chong Chan-Yau

#### Digital technology – a door to opportunities

It is our mission to promote equality, opportunities and independence amongst visually impaired persons (VIPs). We believe that VIPs have the right to equal treatment and the ability to live an independent life. With opportunities available, VIPs can unleash their potentials and contribute to our society.

"Opportunity dawns on the prepared." Hong Kong Blind Union has long been getting ready for the advent of the digital era. In order to improve the lives of VIPs, we have been inventing digital products, software and applications.

In July 2017, I was delighted to have been invited to iLEAP's Transformational Leadership for Change programme organised by Microsoft at its headquarters in Seattle. During the event, community leaders from all over the world exchanged ideas on how to bring about changes to society with the use of digital technology.

Moreover, in order to better understand the latest development of technology around the globe, the staff of Blind Union and myself took part in "California State University, Northridge - the International Technology and Persons with Disabilities Conference" in San Diego, the US in March 2018. These two trips have shown me the unlimited possibilities and opportunities brought by digital technology. Thus, Hong Kong Blind Union must keep our efforts in promoting digital technology.

In addition to this, the long-awaited "Jockey Club Smart City Walk Project" was finally launched in October 2017. With the sponsorship from Jockey Club Charities Trust, we are going to devise an indoor navigation mobile app "Smart City Walk", which assists VIPs and other people in need to walk around independently. As it is our firm belief that digital technology not only serves as a window for VIPs to lead an independent life, but also a door to ample opportunities.

Another encouraging development this year concerns the Marrakesh Treaty, which Blind Union has long been promoting. The government has eventually started a public consultation on the relevant provisions of Copyright Ordinance. Hong Kong Blind Union has been actively involved in various discussions regarding this issue and been in close liaison with relevant government departments throughout this year so as to ensure the equal right of VIPs to access information.

To sum up, this year has been a fruitful one. Apart from digital technology, Hong Kong Blind Union has been developing steadily in various areas. One more highlight of this year is that I was honoured to have received the Compassion Award from the HK & Macau Taiwanese Charity Fund in December 2017, which is a recognition for my contribution to the field of social welfare in the past years. All the award money received will be used for social welfare purposes including for Blind Union's project of "Around the World in Darkness", which encourages members to travel outside of Hong Kong to broaden their horizons.

Last but not least, I would like to extend my thanks to the staff members of Hong Kong Blind Union for their constant efforts, and to the public and various organisations for their unfailing support, only with which "equality", "opportunities" and 'independence" can be realised in the lives of people with visual impairment.

## Executive Director's Report Ms. Ko Pik-kei, Peggy

"Equality", "Opportunities" and "Independence" have always been what Hong Kong Blind Union aims to strive for. We are glad to learn that these goals have been realised in various areas of our work this year.

#### **Development of digital technology**

"Jockey Club Smart City Walk Project" was officially launched in October 2017. It is indeed encouraging for Blind Union that the Project was recommended by the government and sponsored by The Hong Kong Jockey Club Charities Trust. The Project has received the largest amount of sponsorship ever amongst our projects and it is also the largest-scale project of indoor navigation technology in Hong Kong. Under this project, a mobile app called "Smart City Walk" will be devised to help VIPs and other people in need to walk around independently. The government's recommendation and Jockey's Club's sponsorship of this project not only shows the dire need for the service proposed in the Project, but also the recognition of our capacity in promoting digital technology in the past years.

"Jockey Club E-learning for All Project", another important project of Blind Union in recent years, organised "Reading Barrier Breakthrough with E-Learning Symposium 2018" in January 2018, with over 300 participants taking part in it. Guest speakers from overseas including Ms Janette Barrios from the head office of Apple and Mr Neil Jarvis from Blind Foundation, New Zealand were invited to share in the keynote seminar. This showcased the success of Blind Union's effort in building international networks over the years.

#### Rights advocacy

As a self-help organisation, Hong Kong Blind Union puts much emphasis on striving for equal rights for VIPs. One major achievement this year concerns the Marrakesh Treaty, which Blind Union has long been promoting. The government eventually launched a consultation on the amendments of relevant provision of Copyright Law. In fact, Blind Union has been engaging in advocacy work with various government departments since the signing of Marrakesh Treaty in 2013. Therefore, it is delightful to see such significant progress. In the coming year, we are going to be actively involved in the discussion about this issue and in close liaison with relevant departments.

Barrier-free banking services (including the provision of voice navigation ATMs) is another issue that Blind Union has been fighting for in the past few years. With the concerted advocacy efforts of Blind Union and other organisations of VIPs in Hong Kong, The Hong Kong Association of Banks issued in March 2018 the "Guideline on Barrier-free Banking Services", where good banking practices were set out for industry's reference.

#### Services for the elderly

With the ageing population, there is a rising percentage of elderly amongst our members. Sponsored by Zonta Club of Hong Kong East, our Services Centre regularly organised activities for the elderly, hence enriching the lives of our elderly members.

Moreover, we reached out to our elderly members especially those who rarely take part in activities with multiple approaches ranging from phone calls, home visits to case follow-ups. By so doing, we hope to have a better understanding of their conditions and their support networks so that we can introduce to them the services and community resources that they need.

#### **Conclusion**

This year has been filled with challenges but at the same time witnessed countless opportunities. Since I took up this new role, it is with the support of the President, every Executive Committee Member and all staff members that we could achieve such good results this year. In the coming year, we will constantly endeavour in an effort to achieve the three goals of Hong Kong Blind Union.

#### **OUR SERVICES**

#### **Head Office**

- 1. Promoting correct concepts of visual impairment through publications, seminars, exhibition, and so on;
- 2. Participating in advisory committees of the government and other concerned organisations;
- 3. Following up on social policies, promoting equal opportunities and social inclusion;
- 4. Keeping in touch with relevant international and Mainland organisations to learn about the latest service development;
- 5. Building relationship with the public and organising fundraising projects; and
- 6. Publishing newsletters and audio magazines to report on the lives of visually impaired persons and the work of Blind Union.

#### **Services Centre**

- 1. Organising different kinds of social and recreational activities;
- 2. Providing support services to persons with visual impairment and the newly blind as well as their families, including counselling, life adaptation training and service referrals, so as to help them overcome obstacles arising from visual impairment;
- 3. Organising activities for visually impaired elderly, and contacting them regularly by phone calls and home visits; and
- 4. Providing daily living support services, such as case referral, purchasing of aids, and helping to build district support network among our members.

#### **Jockey Club Vocational and Educational Resources Centre**

- 1. Striving for equal opportunities in education by advocating for proper implementation of integrated education;
- 2. Supporting visually impaired students studying in mainstream schools by providing aids and support services to them;
- 3. Organising adult education courses;
- 4. Arranging services, such as recording, text-reading, Braille transcription and tutoring for members;
- 5. Organising personal development and leadership training programmes;
- 6. Providing supported employment services for visually impaired job seekers; and
- 7. Arranging freelance jobs to provide working opportunities for those members who are unemployed.

## **Accessible Digital Technology Centre**

- 1. Conducting research and development of assistive aids suitable for visually impaired persons;
- 2. Providing visually impaired persons with technical support and training in using digital devices;
- 3. Promoting the adoption of accessible digital technology design and application; and
- 4. Providing related advisory services to individuals, schools, employers and organisations.

#### **Accessibility Services Office**

Implementing social enterprise services and the Jockey Club E-Learning For All project to improve community accessibilities as well as provide various kinds of supportive services for people in need;

- 2. Promoting barrier-free community facilities, as well as creating employment opportunities for visually impaired persons; and
- 3. Providing various kinds of supportive services for print disabled students so that they can make the best use of e-learning and break down barriers to learning.

## SERVICE SNAPSHOTS

#### 8.1 Head Office

The work of the Head Office includes members' affairs, rights advocacy, human resources, financial management, external relations and communications. Its aim is to carry out the mission of Hong Kong Blind Union and strive for the rights of visually impaired persons (VIPs).

## 8.1.1 Member affairs

Any Hong Kong resident with visual impairment is eligible to become our Full Member. Any VIP living outside Hong Kong or anyone who supports our mission can apply to be an Associate Member. 48 Full Members and 10 Associate Members joined Blind Union in 2017/18. As at 31 March 2018, we had a total of 1,592 Full Members and 353 Associate Members. The 53rd Annual General Meeting was held on 30 July 2017. 259 members participated and 11 members were elected the Executive Committee Members of 2017/19.

Six member gathering activities were held to encourage members to come together and give their views on our work, and the number of attendance was 232 in total.

#### 8.1.2 **Rights advocacy**

Fighting for equal opportunities and basic rights of VIPs is the aim that Blind Union has been striving for.

Fighting for voice navigation automatic teller machines (ATMs)

We have been asking all banks to provide voice navigation ATMs to enable VIPs to use the machines independently. During the year, with the help of the Equal Opportunities Commission, we got the attention of HSBC, Standard Chartered Bank and Bank of China Group to address the needs of VIPs by installing more than 300 ATMs with voice navigation in various districts in Hong Kong. With this, VIPs can use the ATMs independently.

Moreover, with the concerted advocacy efforts of Blind Union and other organisations of VIPs in Hong Kong, The Hong Kong Association of Banks issued in March 2018 the "Guideline on Barrier-free Banking Services", where good banking practices were set out for industry's reference to provide barrier-free banking services to customers who are physically disabled, visually impaired and hearing impaired.

#### Striving for the rights of people with print disabilities

We have been concerned about the rights to the access to published works for persons with print disabilities, including the visually impaired. Therefore, we have urged the government to amend the Copyright Ordinance so as to be in line with the provisions of the Marrakesh Treaty (the Treaty) adopted by the World Intellectual Property Organisation in 2013, which safeguards the reading rights of people with print disabilities. This includes the requirement for publishers to provide accessible versions and cross-border exchange of published works.

This year, the government eventually considered amending the Copyright Ordinance in accordance with the Treaty and launched a consultation on this. Blind Union is very much looking forward to it and will be in close liaison with relevant government departments, keeping track with the progress of the amendment on the provisions of the Ordinance.

#### **Attending external meetings**

Representatives from Blind Union attended various meetings held by Transport Department, MTR Corporation Limited (MTRC), Housing Department, Link REIT and the West Kowloon Cultural District Authority and inspected their facilities.

In the meetings, they followed up on a number of facilities and services that are closely related to VIPs, including the service quality of bus companies' frontline staff and their next-stop announcement and display system, the installation of escalator audible warning signals at MTR stations with multiple platforms, electronic audible traffic signals and barrier-free facilities in the community.

#### Raising members' awareness on rights advocacy

We have always been encouraging members to understand the basic rights of people with disabilities and fostering their awareness of rights advocacy.

To serve this purpose, we organised a two-day summer camp on 11-12 August 2017, which 17 members joined. Also, we invited representatives from Kowloon Motor Bus Company to a meeting on 15 August, which served as a platform for members to directly voice out their opinion and was attended by 26 members. Moreover, we held sharing sessions on different issues, such as transportation, surroundings and facilities, the Copyright Ordinance and so on. A total of over 30 Executive Committee Members and members attended these sessions, exchanging their views on the issues concerned.

#### Eradicating the barriers to living an inclusive life in the community

This year, we handled a total of 111 cases where members were not able to live independently in their communities. These included 35 cases of inadequate barrier-free facilities in the community, 46 cases related to transport services, five cases on public services such as medical services and housing, four disability discrimination cases, four cases regarding the use of accessible information technology, and 17 cases concerning the service quality of private organisations, personal affairs and other matters.

#### 8.1.3 Public education and communications

We believe that increasing public awareness and acceptance of VIPs is very important for our full integration into the community. Therefore, Blind Union has always endeavoured to promote public education so that the public can have a correct understanding of the life and ability of VIPs and become aware of our needs, making Hong Kong an inclusive society.

The public education group consisting of visually impaired members organised public education seminars and training sessions for 30 schools and organisations during the year. Target groups included frontline civil servants, access co-ordinators and access officers of the government, frontline staff from the private sector and teachers and students from a number of universities, primary schools and secondary schools. A total of around 1,300 people took part.

## 8.1.4 Fundraising activities

About 50% of the funding for our service development comes from public donations each year. The remaining less than 50% is from the government's annual recurrent grant. The donations received are mainly used to support VIPs in education, employment, welfare, social participation and accessible information technology services and to encourage their full integration into society.

## Flag Day 2017

This year's Flag Day was held in Kowloon on 19 August 2017. Around 800 volunteers were involved, raising about HK\$620,000 in total.

#### **International White Cane Day**

In celebration of the International White Cane Day which advocates the spirit of independence for VIPs, we held "Cane-a-thon" International White Cane Day 2017 in Tsing Yi Promenade on 8 October 2017. Around 220 people including 100 members participated and around \$220,000 was raised. During the event, participants walked in pairs, taking turns to wear a blindfold and experience walking with white canes. Also, it was the first time a group of VIPs were invited to walk independently with their white canes during the "Cane-a-thon" Walk, embodying the spirit of independence, which is the core message of the International White Cane Day.

#### Other fundraising activities

Public-spirited members of our society organised various fundraising events for Hong Kong Blind Union. On 10 September 2017, L99 held a charity event of which Hong Kong blind Union was a beneficiary and around \$50,000 was donated to us. Blind Union was also a beneficiary of the charity concert and booth workshop organised by HBS Group on 17 September 2017, receiving a donation of around \$70,000.

#### 8.1.5 Exchanges in Mainland China and overseas

#### Attending conferences and exchanges in Mainland China and overseas

Blind Union highly values the opportunity to connect and exchange with organisations of and for VIPs in Mainland China and overseas. In the past year, we attended various conferences in China and overseas, including the opening ceremony of the e-book library at Sun Yat-sen Library held in Guangzhou in November 2017 and "California State University Northridge-Assistive Technology Conference" held in the US in March 2018. We also held tours to Guangzhou, Singapore and New Zealand in October and December 2017 and February 2018 respectively in which we paid visits to organisations including Guangzhou Institute for the Blind, Microsoft Singapore Ltd., Dialogue in the Dark Singapore and New Zealand Blind Foundation.

#### **Receiving visitors from Mainland China and overseas organisations**

We received a number of visitors from overseas and China's organisations, including Noor Dubai Foundation, Guangzhou Employment and Training Services Centre for the Disabled, Chongqing Special Education Centre and Macau Rehabilitation Affairs Committee.

#### 8.2 Services Centre

The scope of work of the Services Centre (the Centre) is closely related to the life of visually impaired persons (VIPS), including recreational, sports and cultural activities, life adaptation and services for the newly blind. The objectives are to help them live independently and enable them to integrate into the community.

#### 8.2.1 Social and recreational activities

To broaden the social circle of our members, the Centre organised 57 cultural and recreational activities throughout the year. They included local and Mainland tours, sports and recreational activities, dining, cultural and art activities as well as community familiarisation visits. The total attendance of VIPs and sighted companions were 2,176 and 1,251 respectively. In addition, 25 activities were organised by various groups under the Centre. 441 and 126 VIPs and sighted companions took part in these activities respectively.

#### 8.2.2 Continuous learning courses

We provided a variety of continuous learning courses including Cantonese opera class, hiking team, yoga class, ocarina class, a cappela group and qigong class. There were 85 gatherings this year. The total number of visually impaired and sighted participants were 948 and 264 respectively. For some of the courses, public performances were held after their completion, enabling participants to showcase their talents.

#### 8.2.3 Group activities and volunteer training

We regularly held interest groups, including Chinese music group, Karaoke group, card game group and the Leisure Band. The groups had 126 gatherings in total for the past year with 1,528 attendance of visually impaired members. Some of the groups also organised community services and performances to enhance the public's understanding of VIPs. In addition, a total of nine volunteer training sessions were held throughout the year with 124 participants in total.

#### 8.2.4 District-based activities

To enhance interaction amongst members and strengthen their community support network, the Centre promotes a community-based service concept that brings services into the community. We organised activities in our five designated districts, namely the New Territories West, the New Territories East, the Kowloon West, the Kowloon East and the Hong Kong Island. During the year, 60 activities took place in the five districts, ranging from dining, shopping, community familiarisation tours, visits, cooking and so on. There were 1,031 VIPs and 530 sighted companions taking part in the activities.

## 8.2.5 Services for the elderly

Our Centre reached out to the elderly members, especially those who seldom participated in activities with multiple approaches so as to better understand their conditions and support network and introduce to them services of our Centre and available resources in the community.

The focuses of services for the elderly this year were showing care through phone calls, visits and case follow-ups. The Centre continued to collaborate with the Hong Kong Red Cross to pay regular visits to elderly members who seldom participated in our activities. We visited 84 elderly persons throughout the year. Also, our caring group met regularly and made follow-up phone calls to show our concern to our elderly members. 180 phone calls were made throughout the year.

Furthermore, with the sponsorship from Zonta Club Hong Kong East, our Centre regularly organised activities to enrich the lives of the elderly members. The activities included outings during festivals, tea gatherings, tours of the community and talks. The attendances of visually impaired elderly and sighted companions were 310 and 185 respectively.

A new group "Wonderful Elderly" was formed this year. During group gatherings, members were invited to exchange information about the daily life of the elderly or plan services related to the elderly, thus strengthening the support network for the elderly. There were five gatherings this year with the attendance of 41 people.

### 8.2.6 Individual funding programmes

#### **Community Support Service for VIPs and their Families**

Launched in 2015 and funded by the Social Welfare Department, the three-year programme offers counselling for newly visually impaired persons and their carers, tailor-made life skills training and support services for VIPs including case counselling, individual or group training, escort service for medical appointments and personal business as well as community education. The programme enables newly-blind persons to re-integrate into their communities and live independently. The Centre followed up 100 cases from January to December in 2017 to help them overcome the difficulties in their daily life arising from visual impairment. In addition, nine groups and six activities were rolled out to enable newly-blind persons and their families to establish a peer support network. In the same period of time, 146 people used the services of "Escort Service".

The funding from Social Welfare Department for this programme was renewed for three years from 1 January 2018 to 31 December 2020.

#### **Life and Environment Adaptation Programme for VIPs**

This programme mainly assists VIPs who experience challenges due to estate redevelopment, decantation, changing jobs or changes in family or eyesight conditions. During the year, the Centre followed up 24 cases, enabling them to adapt to new travelling routes, to familiarise themselves with the new neighbourhood and thus to live independently.

#### **Counselling and support services**

With the support from The Community Chest of Hong Kong, a total of 34 cases were handled during the year. Workers catered to the needs of individual members by means of emotional support and resource referrals. During the year, a total of two groups and four activities were rolled out, with the total attendance of 71 and 195 VIPs respectively.

#### 8.3 Jockey Club Vocational and Educational Resources Centre

The scope of work of the Jockey Club Vocational and Educational Resources Centre (VERC) includes advocating equal opportunities in education and employment for VIPs, helping them to deal with problems in study and work, and enhancing their personal growth and development.

#### 8.3.1 Educational services

#### **Supportive Services for Visually Impaired Students**

With the support from The Community Chest of Hong Kong, we continued the Supportive Services for Visually Impaired Students. In the programme, the following services were provided:

#### **Counselling and support services**

This year, VERC handled over 40 counselling and support cases. With the use of casework approach, our staff had an in-depth understanding of the needs of individual visually impaired students and provided services for them, including support for their learning, emotional support and resource referrals.

#### One-on-one district-based homework tutoring support services

This year, a total of three phases of "district-based" homework tutoring support services for visually impaired students were organised. We arranged volunteer tutors to have one-on-one homework tutoring for visually impaired students based on their districts of residence and learning needs. 17 tutors served 18 visually impaired students from nine schools, providing a total of 424 hours of services.

#### Personal growth experiential activities

A total of 31 personal growth experiential activities were held this year. 332 VIPs participated in the 67 sessions of these activities and approximately half of them were students. Activities ranged from music, sports, arts, culture, volunteering, craftsmanship, community services and so on. Through these activities, we hoped to facilitate visually impaired students' personal growth. 85% of participants agreed that these activities broadened their horizons.

### Talks on "inclusive campus"/audio magazine about integrated education

The VERC regularly imparts the message of equality and inclusiveness in schools. During the year, we visited 12 secondary schools and held talks on "Inclusive Campus" for 633 teachers and students. We also ran 13 workshops on "Getting to know the visually impaired", which attracted 132 teachers, students, social workers and parents to attend. In addition, we produced 12 episodes of the audio magazine "Integrators' Zone" for the year, which enabled the public to know more about the situation of integrated education for students with visual impairment.

## **Support for parents**

In order to build stronger connection with parents of visually impaired students, the VERC formed a support group for parents in mid-2017. In the group, parents shared their experience of taking care of their visually impaired children. Also, we held an experiential activity for parents where they could have a taste of visual impairment.

#### 8.3.2 Other education-related activities

#### **Group work**

This year the VERC formed four groups. 55 sessions of activities were held for these groups, attracting 41 VIPs to join with the attendance of 158 in total. The themes of these groups included support for parents of visually impaired students, community affairs and advocacy work as well as personal development and communication skills.

#### K.B. Tam Fund for Multimedia Production and Training

With the donation of our member Fred Leung and his family, we set up the K.B. Tam Fund for Multimedia Production and Training. With the Fund, a multimedia room with related hardware and software was set up and its opening ceremony took place on 23 September 2017. Apart from this, with the support of the Fund, various training courses on multimedia software were organised. Members could also apply for sponsorship from the Fund to attend training courses offered by other organisations. For this, a management committee was set up in order to oversee the use of the Fund.

#### **Continuing education**

The VERC organised six adult education courses funded by the Labour and Welfare Bureau during the school year 2017/18 (i.e. September 2017 to August 2018).

These courses included basic first aid, basic word processing, basic labour rights, basic mental health first aid, the use of smart phone and mobile apps, and the application of assistive tools for study and work. Two of these courses were already completed this year with the attendance of 260 and the average attendance rate of 70%. During the year, the VERC also organised a course on Wing Chun martial arts to encourage the all-round development of our members.

#### Leadership training for visually impaired youth

With the sponsorship from the Dialogue in the Dark Foundation, we launched a leadership training programme for visually impaired youth in the beginning of 2018. Through a series of workshops and training, the programme aimed to enhance the participants' acceptance of the identity as VIPs and boost their communication skills and organisational skills. The themes of the workshops included "self - understanding", "forum theatre", "non-violent communication" and "organisational skills". After the workshops, the participants designed a workshop and in April 2018, they will go to Guangzhou to share what they had learnt with their visually impaired counterparts and staff of relevant organisations. It served as a chance for exchange of ideas and at the same time for personal breakthroughs and self-realisation. A total of 13 members participated in the programme.

#### "Around the world in Darkness"-Xinjiang Lop Nor Desert Trip 2017

"Xinjiang Lop Nor Desert Trip 2017" took place from 21 to 29 October 2017. 20 members and 12 sighted companions participated in the trip. The feature of the trip was the emphasis on the use of non-visual senses to experience the beautiful scenery and local customs there.

#### **Scholarships**

The award presentation ceremony of Lee Bing Vocal Music Development Fund and Li Chu Shuk-kwan Education Fund this year took place at the auditorium on the 6<sup>th</sup> floor of CCC Kung Lee Church in Causeway Bay on 25 March 2018.

The scholarship for Li Chu Shuk-kwan Education Fund was presented to six students while the Scholarship for Lee Bing Vocal Music Development was awarded to three students.

Also, six visually impaired students nominated 22 teachers and classmates for the awards of Good Mentor Commendation Scheme. As it was the 10<sup>th</sup> and 5<sup>th</sup> anniversary of the two scholarship schemes respectively, some of the past awardees were invited to share their feelings and to express their gratitude to Rev. Lee in order to mark this special moment. On the same occasion, two past awardees of the Scholarship for Lee Bing Vocal Music Development, Siu Hoi-yan and Lee Hin-kwai, were appointed as Vocal Ambassadors to promote the development of vocal music.

#### 8.3.3 Career development services

#### **Supported Employment Services**

We continued to provide Supported Employment Services funded by the Social Welfare Department. Services were provided to 40 VIPs every month on average. Throughout the year, services were provided to 48 service users. Among them, 12 persons were successfully employed (i.e. being employed for more than six months and receiving a monthly salary of more than HK\$1,500).

In addition, we assisted two members to apply for the Social Welfare Department's Support Programme for Employees with Disabilities and Jockey Club IT Scheme for People with Visual Impairment respectively to purchase assistive tools and computers.

#### **Employment-related programmes and/or activities**

#### Training scheme for IT support personnel

The training scheme for IT support personnel funded by Microsoft HK was held between June and July 2017. Eight members participated and completed 18 hours of training. Through lessons, practices and visits to IT companies, participants had a deeper understanding of the IT industry and learnt the basic skills of Excel. After completion of the programme, participants regularly joined the exhibitions and workshops jointly organised by Microsoft and WebOrganic, keeping abreast with the latest development of accessible technology.

#### e-Connect Employment Network

Since 2016, we set up the e-Connect Employment Network with five social service organisations (namely Baptist Oi Kwan Social Service, The Hong Kong Society for the Deaf, Hong Kong PHAB Association, The Hong Kong Society for Rehabilitation and Richmond Fellowship of Hong Kong) in order to connect the passionate companies and expand the employment opportunities for people with disabilities and people with chronic illnesses. The Network held regular employment-related events such as mock interviews, "Research on employment status of persons with disabilities and persons with chronic illnesses 2017", a large-scale job fair cum employers' sharing session and 10 mini-job fairs.

#### Recruitment and briefing session of telephone liaison officers

We collaborated with an insurance company and held a recruitment and briefing session for the job of telephone liaison officer in December 2017. During the session, participants were introduced the job details of a telephone liaison officer and suitable VIPs were selected for the jobs. Eventually, three VIPs were hired.

#### 8.3.4 Advocacy and research

#### **Education**

#### **Support for HKDSE candidates**

The VERC collected the views of the candidates of the past HKDSE between July and August 2017. A meeting was arranged with the Hong Kong Examinations and Assessment Authority, where we followed up on the suggestions we made this year and in the past four years. The responses were positive with most suggestions being accepted and considered. It is hoped that this will enable visually impaired candidates to have fairer examination arrangements in the future.

#### **Employment**

#### Joining the Alliance of Employment Quota System for Disabled Persons

Representatives from the VERC were involved in the work of the Alliance of Employment Quota System for Disabled Persons. On 29 August 2017, we attended a meeting with the Secretary for Labour and Welfare Dr Law Chi-kwong, in which we followed up on the formulation of the Rehabilitation Programme Plan (RPP) and discussed the employment quota system for disabled persons. On 8 December 2017, we met with representatives from Labour and Welfare Bureau, Civil Service Bureau, Social Welfare Department, the Selective Placement Division (SPD) of Labour Department and General Grades Office, discussing issues including the employment of disabled persons as civil servants, Disability Allowance, open employment of disabled persons and residential care homes for persons with disabilities. On 28 December 2017, representatives from Blind Union attended a meeting with representatives from the SPD of Labour Department, reflecting to them the difficulties VIPs had encountered when using their services.

#### Establishing a mechanism of regular communication with the SPD of Labour Department

This year, Blind Union started regular communication with the SPD of Labour Department, expressing VIPs' opinion about their services and thus facilitating more equal right to use the services of the SPD. Representatives from the SPD visited the VERC in February 2018 to understand the assistive tools of VIPs and tips to communicate with VIPs, enabling them to better assist VIPs with employment in the future.

#### Research on the current employment situation

Collaborating with Prof Wong King-shui, Phyllis of The Chinese University of Hong Kong's Department of Social Work, Blind Union engaged in the research on the employment of VIPs in the hope of shedding light on the employment condition of VIPs and making recommendations on the relevant policies. The research team started inviting VIPs to participate in the survey in early 2018, and we expect to release the results in mid-October 2018 in line with the International White Cane Day.

#### 8.3.5 Education of VIPs in China

With the Education Fund for People with Visual Impairment in China set up in 1999, Blind Union provided financial aid to visually impaired students in China so that they could continue their education despite poverty. We also promoted the cultivation of visually impaired children in China so that they could enjoy equal right to education, thus being able to unleash their potentials and contribute to society.

#### A forum on the employment of China's VIPs

Representatives from Blind Union attended the "Forum on the employment of China's VIPs" organised by Binzhou Medical College in Yantai City, Shandong, from 20 to 23 June 2017. With the theme "Breakthrough", representatives from Hong Kong shared the experience in inclusive education and employment and ways VIPs should equip themselves. A Hong Kong employer, Ms Kong Lai-ping of Sunshine Laundry, was also invited to share her experience of hiring VIPs.

#### Experiential learning programme for China's visually impaired tertiary students

In collaboration with The Chinese University of Hong Kong (CUHK), we arranged four visually impaired students from Shandong Binzhou Medical College to have experiential learning at CUHK from 25 September to 7 October 2016. CUHK arranged accommodation and for the students to sit in on different classes to help them understand the situation of inclusive education in local universities. Outside of their classes, Blind Union organised visits and exchanges with our executive committee members and other members.

#### Support for visually impaired students in China

This year, we continued to provide assistance to students in Meizhou, Zhanjiang and Binzhou Medical College, supporting their studies with scholarships. Our representatives paid a visit to Meizhou Special Education School in April 2017 and visited the sponsored families.

#### 8.4 Accessible Digital Technology Centre

The Accessible Digital Technology Centre aims at improving daily lives of visually impaired persons (VIPs) with the use of technology. Our work scope includes the development of assistive aids, technical support and training, promotion of accessible technology design and application, and provision of support and consultancy services to organisations and needy individuals.

## 8.4.1 Jockey Club Smart City Walk project

Hong Kong Blind Union has always been endeavouring to improve the lives of VIPs with information technology. Recommended by "HKSAR Chief Executive's Community Project List" and funded by The Hong Kong Jockey Club Charities Trust, we launched the four-year Jockey Club Smart City Walk project in October 2017. With the rapid development of technology, mobile apps strengthen VIPs' and the elderly's connection with the world and enable them to live independently. In the Jockey Club Smart City Walk project, we developed an indoor navigation mobile app, the "Smart City Walk" with the combination of different positioning technologies. The app will guide users to their destinations with text and audio outputs, enabling VIPs and other people in need such as the elderly to walk around independently with ease. This project will provide training to VIPs and the elderly on the use of information technology so that they can better integrate into society. At the same time, talks and sharing sessions will be held to raise public's concern about VIPs.

In order to better understand the latest development of indoor positioning technologies, we visited various organisations for and of VIPs and IT companies in China and overseas with funding from the project from October 2017 to March 2018. For details, please refer to the section on "Exchanges in Mainland China and overseas" about the work of Head Office.

We expect that this mobile app will be launched in the first quarter of 2019 with iOS and Android versions available.

#### 8.4.2 Organising IT interest groups

IT interest groups of various themes including smartphone application and IT skills and knowledge enhancement were regularly organised for members during the year. To embrace better skills and the latest trends, members shared with each other in the gatherings their experience and information about new products. Each group held 28 gatherings with 184 attendances during the year.

#### 8.4.3 IT training and support

Five hands-on workshops on the usage of software were organised and the number of attendance was 34 in total. Helpdesk service was provided to support members' enquires on software and assistive aids. 2,056 phone-in and 188 face-to-face enquiries were handled during the year.

An issue of "Accessible Digital Technology Newsletter" was published every month to help subscribers keep abreast with the latest technology. There were 426 subscribers and about 44,000 webpage hits.

#### 8.4.4 Development and enhancement of assistive software and mobile applications

With the funding from The Jockey Club e-Learning for All Project (ELFA), we continued the development and enhancement of various software and mobile apps. Our tasks included the development of a new EasyDots Chinese Input Method that can be used on Apple Mac machines and adding a new English format UEB to the Braille transcription software Brite. In addition, we continued to upgrade the NVDA add-on to strengthen support for Windows 10 and above, and to improve the mobile app "iEasyDots" on both Apple iOS and Android platforms in order to provide better support for the new models of mobile phones.

## 8.4.5 **Development of internal IT management system**

Funded by the Social Welfare Development Fund of the Social Welfare Department, Blind Union launched two projects in order to upgrade the infrastructure of information technology and to enhance our management.

- We developed a new information dissemination system by improving the existing telephone hotline system, and by making our information available through a mobile app or on our website so as to make it easier for VIPs to access our information.
- We also transferred our internal email server to the Microsoft Cloud Platform System. Our email system was then managed with Microsoft Exchange Online, so that its security and stability could be enhanced.

#### 8.5 Accessibility Services Office

#### 8.5.1 Jockey Club E-Learning For All Project (ELFA)

Funded by The Hong Kong Jockey Club Charities Trust, the Project provides supportive services for print disabled students from primary to tertiary level.

As at March 2018, a total of 322 individual students and 95 schools with 3,184 print disabled students registered as service users in the Project. This year, 1,037 electronic learning materials or textbooks (33,611 print pages in total) were transcribed and 446 tactile learning materials were produced for students in needed. Training workshops and social support activities were organised with the number of attendance of 300. About 950 copies of software and applications developed by Blind Union were distributed for free.

Under the Project, an online platform was set up providing a variety of services such as free online OCR (Optical Character Recognition) service, accessible e-book bank and bi-monthly e-learning newsletters. This year, we produced microfilms and a collection of users' sharing, took part in the Learning and Teaching Expo and conducted a study in collaboration with The University of Hong Kong looking into the impacts of e-learning tools and resources on print disabled students.

#### "Reading Barrier Breakthrough with E-Learning Symposium 2018"

The symposium was held on 30 January 2018 at Hong Kong Productivity Council with the theme of "Information Technology Bringing Opportunities for Inclusive Schooling- Accessible Learning Materials and Holistic Development". It provided a platform for connection and exchange of ideas where industry practitioners, professionals, academics, students and parents reviewed the experience of the development of e-learning in Hong Kong in the past, and explored the latest development of the information technology concerned and the opportunities brought to the print disabled students. It was a major event under the project.

Over 300 guests participated in the event which consisted of a keynote seminar, panel discussions, workshops and exhibitions. Amongst the keynote speakers were experts from overseas such as Ms Janette Barrios from the head office of Apple and Mr Neil Jarvis from Blind Foundation, New Zealand. Other speakers included Mr Fred Sheu of Microsoft Hong Kong and representatives from Education Bureau, Hong Kong Examination and Assessment Authority and Intellectual Property Department.

## 8.5.2 Social enterprise services

Operating on a social enterprise model, Blind Union strives to promote barrier-free community facilities, acquire suitable daily commodities, as well as create employment opportunities for visually impaired persons. Our social enterprise business responds to the HKSAR Government's targets of promoting barrier-free facilities and services, playing a leading role in building an inclusive society.

### Web Accessibility For All (WAFA)

Funded by the Home Affairs Department's "Enhancing Self-Reliance Through District Partnership Programme (ESR Programme)", the social enterprise Web Accessibility for All (WAFA) was set up in 2013 to promote accessible digital technology. This year, WAFA provided testing and consultancy services to more than 250 web pages and mobile apps.

#### Production of tactile maps and consultancy for audio systems

In response to the government's policy of promoting accessibility, the enterprise continued to produce and provide consultancy services for tactile maps and audio systems as well as engage in the production and sales of tactile signage. To cater for the needs of different people, our services were provided with references to the standard in the Buildings Department's "Design Manual: Barrier-free Access 2008", and also views given by our staff and members with different levels of visual impairment.

#### **EasyBuy**

To ensure the products selected met more of our members' needs and to tap the self-help spirit, we invited several members to form a group to help source more suitable products and widen the choices of economical and quality goods for other members. Since 2016, we also started adopting group-purchase so that members could acquire high quality products with a low price tag.

## **Braille / text transcription services**

Our social enterprise provides the service of adding names, phone numbers and other information in Braille on ordinary name cards. Our services also include converting printed materials, Braille and audio files (such as interview recordings) into text or Braille format. Target customers include government departments, private companies, social welfare agencies and tertiary institutions. Our business not only provides job opportunities for visually impaired people but also makes information accessible among the visually impaired, the public and related organisations.
